Atwood introduced Resolution 19-18 Authorizing the Borrowing for Funds – KLP for \$200,000 at 0% interest, second Shipley. Motion carried 5-0.

Shipley introduced Resolution 20-18 Street Finance Report 2018, second Peacock, Motion carried 5-0.

City Administrator Padget updated the council on the following items:

The judge awarded the property 210 Lucas Street to the City on August 23, 2018.

More estimates for the demolition of 607 & 611 First Street will be coming.

The judge ordered the City to abate the nuisance at 201 Chestnut.

The nuisance at 601 Dodge Street was continued for 2 weeks, while the dog is being re-located outside the City limits.

Motion Peacock, second Shipley to approve the Pool Easement Agreement with the City of Keosauqua and Van Buren Recreation Area. Shipley clarified that "without facilities like the pool and the sports complex the city cannot move forward". Motion carried 4-1, (Lazenby nay).

Deer Hunting inside the City limits was discussed. There have been many concerns expressed by citizens regarding safety if this were to be allowed. Council took no action at this time.

Job Descriptions were discussed. Overtime policy, organization for management and identifying what is needed for the operation of pool will be addressed at the September council meeting.
Motion Lazenby, second Shipley to approve building permit for new sidewalk at the Keosauqua Senior Center. Motion carried 5-0. Nuisances at 501 First Street and 901 6 th Street were discussed.
Motion Shipley, seconded Atwood to adjourn at 5:00 pm. Motion carried 5-0.
