ON AN AERIAL MAP OF THE PROPERTY, WHICH CAN BE OBTAINED FROM THE VAN BUREN COUNTY ASSESSORS OFFICE LOCATED AT THE COURT HOUSE, DRAW THE STRUCTURE YOU WILL BE CONSTRUCTING. THE FOLLOWING MUST BE INCLUDED FOR COUNCIL ACTION:

1. The dimensions of the structure.
2. Number of FEET FROM ALL PROPERTY LINES MUST BE SHOWN for the proposed new structure.

NOTE THE FOLLOWING SETBACKS: FIVE (5) FEET FROM EACH SIDE OF THE LOT(S) LINES AND TWENTY-FIVE (25) FEET FROM THE FRONT AND BACK PROPERTY LINES. CORNER LOTS REQUIRE TWO (2) 25 FOOT FRONT SETBACKS.

ALL SUBDIVISION COVENANTS MUST BE FOLLOWED FOR THIS BUILDING PERMIT TO BE APPROVED. APPLICANT CERTIFIES THAT ALL WORK DONE UNDER THIS PERMIT SHALL BE IN STRICT CONFORMANCE WITH THE MUNICIPAL CODE OF THE CITY OF KEOSAUQUA, THAT NO WORK SHALL BEGIN UNTIL THIS PERMIT HAS BEEN GRANTED AND THAT S/HE UNDERSTANDS THAT ANY VIOLATION OF THE CODE CONSTITUTES A MISDEMEANOR, LIABLE TO PUNISHMENT THEREOF AND WITH ANY EXISTING OR FUTURE LAWS OF THE STATE OF IOWA AND ORDINANCES OF THE CITY OF KEOSAUQUA, IOWA.

BUILDING MATERIAL AND ANY DEBRIS FROM CONSTRUCTION MUST BE COVERED OR SECURED TO KEEP FROM BLOWING AND LITTERING NEIGHBORING PROPERTIES.

BUILDING PERMIT PROCEDURES FOR THE CITY OF KEOSAUQUA

1. A building permit is required for any exterior structure constructed in a permanent manner which includes new dwellings, garages, additions, fences, sidewalks, decks, breezeways, porches, storage sheds along with moving any structure onto a property. The completed Building/Zoning Permit Application must be returned to City Hall at 804 First Street. If you have any questions, please call (319) 293-3536. Once approved, the building permit is valid for one year
2. Sidewalks that do not connect to city property do not require permits.
3. Driveways that do not connect to city streets do not require permits.
4. The rebuilding of decks does not require a permit unless the dimensions change.
5. An aerial map is required showing the lay out of property lines, street names, existing structures, and the proposed structure. Measurements showing the distance from the property line to the proposed structure must be displayed.
6. Estimated costs of the building structure are required and must be listed on the building permit application.
7. You may be eligible for tax abatement. Application forms are available from the city clerk and must be approved by the City Council before being submitted to the Van Buren County Assessor's Office.
8. Always call Iowa One Call (800-292-8989) before digging. All utility services will locate underground service lines on your property without charge.
